Requiring MUHS 3703 or 3713 to the minor requirement (Music History I or Music History II) will add some upper-level work to the minor, bringing the minor more into line with other departments in Fulbright College and with other music departments nation-wide. The music history sequence of MUHS 3703 & MUHS 3713 is required for all music majors, but we have decided to let minors choose between the two, rather than requiring both. MUTH 1603 and 2603 are Music Theory I and II, respectively, which are our most basic academic courses. MUTH 1603 and 2603 are prerequisites for the Music History sequence of MUHS 3703 and MUHS 3713.

MLIT 1003 has been another prerequisite for MUHS 3703 and 3713. MLIT 1013 is being proposed as the music lecture class for music majors, and it will become the prereq for MUHS 3703 and 3713 once approved; therefore, since MUHS 3703 or 3713 are being required for the minor, we wish to specify MLIT 1013 as a required course.

The overall minimum number of credit hours required for the minor will remain 18.

The student must notify the Department of Music of his/her intent to minor.
