I hope that I have addressed your request for course information. If not, let me know.

HLSC 1002 had been required within the GHES program of study within the School of Human Environmental Sciences. When this course was deleted and the designation changed to CHLP, the CHLP 1103 course was listed in its place.

The GHES program of study requires that selective courses from all areas of study be taken; therefore, when HESC 4813 (Human Factors in Interior Design) was moved to ARCH, another courses had to be used to address housing issues. CATE 4803, as taught by Dr. Cecelia Thompson in EDUC, does include a housing component. CATE 4803 has been used in the past as a course substitution, but now is being required as a replacement for the deleted HESC interior design course.

HESC 1603 has been added to the required HESC courses so that the Hospitality area can be represented within this GHES program of study.
