**HESC 3604 will become HESC 3603 (lecture) and HESC 3601 (lab) in 2013. The lab component will not be required in the General Foods and Nutrition concentration. HESC 4103 will no longer be required in the GFNU concentration. This will bring the GFNU concentration into compliance with Act 747. The course content in the General Nutrition minor is a duplication of course requirements in the GFNU concentration, therefore, students choosing the GFNU concentration will not be eligible for the minor.**
