Insert here a statement of the exact changes to be made: The Department of Anthropology plans to change major requirements for the Anthropology BS program, replacing "Approaches to Archaeology" and associated lab (ANTH 3023/3021L), with a new course "Introduction to Archaeology" (ANTH 1033). Three hours of additional ANTH upper-level electives will also be added to replace this upper-level requirement, resulting in an overall increase in the number of hours required by the major from 55 to 57. Adjustments to the 8 -semester plan were required to refelct these new requirements and to be sure that students remained in compliance with the college's 24-hour rule ( 24 hours of Fulbright 3000+ coursework required), the University's residency requirement " 30 -hour rule" ( 30 hrs of $3000+$ coursework required) and the college's " 40 hour rule" ( 40 hrs of advanced-level coursework required, which may include 2000 -level courses which have prerequisites).

The Department of Anthropology course offerings are primarily in the subfields of cultural anthropology, biological anthropology and archaeology. 1000-level introductory courses are available in cultural (ANTH 1023) and biological anthropology (ANTH 1013/1011L) but not in archaeology. With this new course, ANTH 1033, we propose to address and correct two related issues that affect undergraduate students on this campus. First, we wish to offer an introductory course with the same general appeal and broad content typical of the two introductory courses in cultural and physical anthropology. Second, for those undergraduates who wish to pursue archaeology beyond this introduction, this new course would provide the appropriate foundation for archaeology coursework at a more advanced level. Thus, the proposed course will replace ANTH 3023/3021L as the introductory Anthropology major requirement, enabling us to expand the size of the introductory class considerably. The increased class size will allow Anthropology majors to enroll in the course with less difficulty and will allow a much larger number of non-majors to enroll in the class as well. We do not anticipate that this change will impact any other degree programs, and no program components will be eliminated.
