PROGRAM INFORMATION

7. Reason for offering program by distance technology:

There is increasing demand for distance education opportunities in the specialized LL.M. Program market. Many law schools are developing new LL.M Programs with online courses and expanding their face-to-face LL.M. Programs to incorporate distance education. We anticipate that the demand for distance education will continue to expand in the future.

The LL.M. Program in Agricultural & Food Law is the only LL.M. Program in the United States that offers the LL.M. degree in this area of study. As was reported by our external reviewers in our Program Review last year, "Agricultural and Food Law is a developing area of law and is needed not only locally and nationally, but globally as well. The University of Arkansas program is ideally positioned to be a leader in this field and currently has that status."

Because we draw our students from a national and international market, our Program is particularly affected by the demand for distance education. We are currently losing talented applicants because they cannot relocate to Fayetteville for our face-to-face classes. Distance education offers not only

growth opportunities, but will be necessary to maintain our leadership position in the developing marketplace.

We propose the development of a distance track for the LL.M Program in Agricultural & Food Law that will integrate our face-to-face delivery with distance education opportunities. This will allow us to increase the size of our enrollment while maintaining or increasing our high standards of admission. It will allow us to provide a greater range of classes and experiences to our students. And, it will allow our face-to-face students to interact and network with fellow-students throughout the U.S. and international countries who would not otherwise be able to attend our Program.

With the assistance of the UA Global Campus, our distance course offerings will offer a fully integrated classroom experience, taking advantage of state-of-the-art technology for synchronous video conferencing, blended course delivery, and the full range of interactive online educational experiences.

We are currently offering one class with online student participation. It is taught by a tenured UA faculty member. The course is *Food Law & Policy*, LAWW 7863, and it is taught by UA Professor Susan Schneider. It is a face-to-face class with 2 online students participating through synchronous video conferencing.

LL.M. Program course syllabi are provided as separate documents. These syllabi represent the face-to-face courses in the LL.M. Program that are being developed as integrated distance education courses through UA Global Campus.

Each distance course will be offered for blended delivery. Each will have all course materials available online, provide the opportunity for synchronous video-conferencing interaction, provide compressed video recordings for later viewing of class sessions as appropriate, and provide for online communication and assessment.

Each of the proposed courses is designed to be delivered to no more than 15 distance students.

Class interaction will be accomplished through live video-conferencing, electronic bulletin boards, blogs, email and chats. In addition, course activities will incorporate group assignments that require online collaboration. Distance and face-to-face students will take classes together and interact regularly.

11. Discuss the provisions for instructor-student and student-student interaction that are included in the program design and the course syllabus.

The program design incorporates an almost seamless integration of the face-to-face students, the distance students, and the instructors. All will work from an online platform on Blackboard where all course materials, presentations, exercises, and related course components are housed.

Face-to-face classes will bring together the Fayetteville students and the distance students using synchronous video-conference technology and a blended delivery mode. This technology provides for complete interactivity in the classroom. A "flipped" classroom model will offer an opportunity for high-level interaction during these conferencing periods. Additional opportunities for student-to-student interaction will include blogging, electronic bulletin boards, group assignments, and extra-curricular conferencing options.

Several special condensed courses will be offered each year on campus as electives to provide an opportunity for distance students to come to Fayetteville for several days and earn credits in in a face-to-face setting if they choose.

Some of our elective courses will only be offered with face-to-face delivery periodically, e.g., every other year. When a course is not offered, an updated online version will be available with interactive exercises and significant student-teacher interaction built into the course. This interaction will include video-conferenced discussion sessions with the professor and other students enrolled, online exercises with professor supervision and commentary, blogging and email exchanges, and interactive assessment. The offering of online electives will allow for expanded opportunities for both face-to-face and distance students.

In all classes, distance students will interact with their professors through video conferencing, phone calls, and emails, with additional interaction through commentary on assignments and examinations.

12. Provide a semester-by-semester degree plan/course schedule for student access to all courses necessary to complete the program.

All degree requirements will be the same for distance students and face-to-face students. The program plan for the distance program is based on almost complete integration of the face-to-face and distance tracks. With the exception of several condensed courses offered each year on campus, all LL.M. coursed offered will be modified to accommodate distance students.

Twenty-four (24) credits from approved courses are required for the LL.M. degree. There are 6 courses (for a total of 8 credits) that are required courses. The remaining 16 credits can be earned through approved elective course credit.

The required courses are offered once each year face-to-face, with a distance option available. Four of these courses are offered in the Fall Semester (for a total of 5 credits), 1 course is offered in the Spring (2 credits) and 1 course consisting of an independent research article completed with professor supervision, is available at any time. These face-to-face required courses allow for distance student enrollment with participation through synchronous video-conferencing and blended distance education tools built into the face-to-face course.

In addition to the required courses that are offered each year, at least 16 credits of elective courses are offered face-to-face, with a distance option available. It is therefore possible for any full time student (face-to-face or distance) to complete the Program in 2 semesters. Both face-to-face and distance students, however, each have 4 years from matriculation within which to complete the Program. It is anticipated that most of our distance students will attend part time.

In addition to the required and elective courses that are offered face-to-face with a distance participation option, additional electives will be available. Courses that are not offered as face-to-face classes with synchronous video conferencing will be available as updated online courses offered with interactive exercises and significant student-teacher interaction built into the course.

All services to our students will be provided by University of Arkansas faculty, staff, and administration. The School of Law is receiving support from the UA Global Campus in developing the new distance track.

14. Estimate costs for the proposed distance technology program for the first 3 years. Include faculty release time costs for course/program planning and delivery.

The Program design anticipates the creation of a significant new revenue stream from distance enrollment. All development costs should be recouped from this revenue stream within a reasonable period of time. We anticipate that significant program development will occur throughout the current academic year (2013-2014). With ADHE approval, we would like to begin admitting degree students to the distance track Fall 2014. The first two years will be focused on continued course development and implementation. The Program should be fully implemented by Fall 2016.

Because the Program is an ongoing effort dependent upon existing faculty, assistance is needed to develop the distance courses without disrupting current delivery of the face-to-face courses. One additional faculty member (a recent graduate hired at an assistant professor level on a contract basis) has been assisting with the development of the new distance courses since May 2013. She is working closely with UA Global Campus course designers. Her contract will run through academic year 2014-2015 (two full years).

We have requested assistance from Global Campus in hiring a second temporary contract faculty member to help implement the distance track and assist with marketing, program development, and quality assurance during the first two years of implementation. That request is pending.

These two hires will allow our existing tenured faculty members to continue teaching without

any release time.

Once fully operational, we anticipate that the Program will need one full time faculty member to join the Program faculty, although this new position would be dependent upon revenue from new student enrollment.

Additional administrative costs will be associated with the increased enrollment in the Program. This will require a position upgrade for the administrative staff person that currently assists the Program Director.

Technology upgrades in the LL.M. classroom are anticipated for the Summer 2014, although the video conferencing licenses have already been purchased campus-wide.

Additional costs will be incurred to support adjunct course development as face-to-face courses are transitioned to a more suitable blended delivery mode. Adjunct teachers currently receive \$3,000 per credit for teaching with no travel allowance. We have a request pending with Global Campus for additional support for adjunct professors to be used in course development and teaching.

It is budgeted that within 5 years time, added tuition associated with the increased enrollment will generate sufficient income to make the Program profitable.

The Graduate Legal Studies Committee approved the proposed distance curriculum and degree track in August 2013. The curriculum and the proposed distance track were presented to the School of Law faculty and approved on September 2, 2013. The proposed distance track will be considered by the University Committee on Programs and Curriculum at their October meeting.
