8. Proposed option/concentration/emphasis name: Add Two Concentrations: Generic and RN-BSN

- 9. Reason for proposed action: Distinguishing two concentrations within the bachelor's degree in nursing, establishes clarification for necessary for program admissions, advising, and degree audits. Each program of study leads to BSN degrees at completion but following very different paths to accomplish it once admitted to nursing school. Both programs require 120 hours to complete and follow similar first 60 hours varying at the nursing requirement level the RN to BSN online program is a 29 credit-hour degree completion program with 37 hours held in escrow for RNs with an associate's degree or diploma in nursing who desire to complete their bachelor's degree online and the Generic program is a complete in-depth study of nursing for individuals who have no previous history of nursing instruction.

The BSN program needs two concentrations: (1) Generic, and (2) RN to BSN. These changes will establish that though both concentrations culminate in a bachelor's degree each have different admission criteria, program of study, and delivery methods.

NURS 4383 Introduction to Nursing Research (Sp, Fa)

COURSE DESCRIPTION: This course provides an overview of health care policy orienting students to the political and social processes impacting the current health care environment. The course provides a basic framework for understanding the role of nursing in advocacy, leadership, economics and ethics associated with influencing health care policy. Recognizing the financing of health care and the impact on quality through policy changes will be discussed.

NURS 4313 Pathophysiology for RNs (Sp, Fa) 3

COURSE DESCRIPTION: The course focuses on the study of the underlying concepts of physiological functioning and the body's adaptive and compensatory mechanisms within a systems framework. Learners examine aspects of disease processes including etiology, pathogenesis, and clinical manifestations, as it applies to current nursing practice with diverse clients across the lifespan.
