This change will simplify academic advising by providing an equitable approach in the awarding of credit for 1003 Elementary I language courses for all University of Arkansas students, and thus aid in retention and degree completion for students. Students who do not meet the long-standing Fulbright College of Arts & Sciences admission requirement (at least 2 units of a world language at the high school level) will still be required to complete one semester of language study (1003 Elementary I of a world language); however, these students will now be allowed to receive degree credit for that course. Similarly, any Fulbright student who wishes to enroll in a world language course at the 1003 Elementary I level, or receive credit for a world language 1003 Elementary I course by advanced achievement in a higher level course, will be able to do so (including any student who has already met the Fulbright admission requirement).
