Disability Policy Concentration

Disability policy focuses on the policies and systems that provide benefits, services, and civil rights protections for people with disabilities. Study in this concentrations may include examination of the history of disability policy; the roles various policy stakeholders play in developing and changing public policy; the contemporary arrangement of services, benefits, and costs; and the political, economic, and social effects of disability policy. The concentration emphasizes an interactionist perspective on disability and relationships between these policy areas and broader societal concerns such as labor, family, community, and cultural issues.

Course of Study (12 hours)

The concentration requires twelve hours of coursework. The two required courses are:

RHAB 6203--Disability Policy in the U.S.

RHAB 605V--Independent Study
