Program Requirements and Description

Requirements

Admission: Students who earn a grade point average of 3.0 or higher in art (after the completion of ARTS 1919C, ARTS 1929C, and a three-credit hour introductory course in their desired concentration) and who have maintained an overall grade point average of 2.0 or higher are eligible to apply to the Studio Art B.F.A. degree program (STARBFA). In addition to meeting the required grade point average, all students must submit, as part of their application, a portfolio of current representative work for evaluation by the art faculty. Acceptance into the program is contingent upon favorable evaluation of the applicant's portfolio by the art faculty.

Transfer credit will be allowed from other accredited and recognized art departments and schools if the credit earned is compatible with program and course requirements within the UA School of Art and reflects a grade of "C" or higher. The UA School of Art will not accept more than 50 percent of the required B.F.A. degree credits from another institution, and it will require a portfolio review for acceptance of all studio art transfer courses above the foundations level.

Program Requirements: The Bachelor of Fine Arts degree will be awarded to students, who, upon the completion of the approved program, have maintained a 3.0 grade point average within the UA School of Art and a 2.0 grade point average overall. Students in the STARBFA program whose grade point average falls below 3.0 in UA School of Art classes for two consecutive semesters will be dismissed from the program. While in the program, students are required to participate in a faculty-supervised critique once each semester. Finally, a senior exhibition is required prior to completing the program.

University and College Requirements for a Bachelor of Fine Arts in Studio Art

In addition to the Fulbright College of Arts and Sciences Graduation Requirements (see under Degree Completion Program Policy), the following course requirements must be met. State minimum core requirements may vary by individual, based on placement and previous credit granted. Once all state minimum core requirements are met, students may substitute with general electives in consultation with their academic advisor.

Description and justification of the request

Description of specific change	Justification for this change
Made changes to admissions language and non-course program requirements. Removed the off-campus study requirement.	These are mostly minor changes that align the program language with other advising documents. We struck the off-campus study requirement as it has become untenable to manage with enrollment growth—no one was willing to not graduate a student for not submitting documentation fulfilling this requirement.
Deleted focused studies and added concentrations.	A focused study is a set of courses that a student may elect to take as part of the major, but is not required. Effectively we have already been acting as if we have concentrations by requiring students to choose one of six media areas as a focused study to graduate with a STARBFA degree. This change aligns the STARBFA degree with program definitions set forth by the university.

Description of specific change	Justification for this change
Minor changes to course requirements.	These changes are designed to provide more flexibility for students when building their schedules. Currently students have a difficult time scheduling studio courses against the other requirements. Too often STARBFA students are switching to the BA degree in order to graduate in 4 years.
