This is accomplished through independent research projects in ~~design studios and art/design studio art and/or art~~ history ~~courses~~ under the direction of the art faculty. ~~Outstanding achievement is recognized by awarding the distinction "Art Scholar Cum Laude."~~ Students ~~must declare honors prior to the start~~ may apply for honors studies beginning in the second semester of ~~spring semester~~ their sophomore year and normally will not be accepted into the program after completion of ~~their sophomore~~ the second semester of their junior year. The ~~School school~~ requires each applicant to have a minimum cumulative ~~GPA grade-point average~~ of 3.5 ~~as well as in all college course work~~; a minimum ~~GPA grade-point average~~ of 3.5 in ~~courses from all course work taken in the School School of Art. Art, completed ARHS 2913 and ARHS 2923, completed at least 20 semester hours of work in art school courses, and at least 30 semester hours of general education requirements.
