

Furthermore, applicants who present a GRE score of 1200 or greater on the combined verbal/quantitative portions, a GRE writing score of 5.5 or greater, an overall GPA of 3.85 or higher, and faculty approval may apply for admission to the Ph.D. Kinesiology program after completion of their bachelor's degree.

## Requirements for the Doctor of Philosophy Degree: A

minimum of 96 graduate credit hours beyond the baccalaureate is required for the degree. A doctoral advisory committee will be established by the student in consultation with the Coordinator of Graduate Study during the first semester of enrollment subsequent to acceptance into the degree program.
