9. Reason for proposed action:
The University of Arkansas no longer has a Middle Level Program, leaving only a P-4 or 7-12 initial licensure option for teacher candidates. There is a great need in Arkansas for teachers who are highly qualified and certified to teach grades 5 and 6. The U of A does have an additional licensure program, or endorsement, in grades 5 and 6 only that can be added to a standard teaching area in grades P-4. The courses for this program currently exist and are approved by the Arkansas Department of Education as an Additional Licensure Program of Study. This modification does not require new courses, new faculty, or resources.

The Childhood Education faculty unanimously approved this change at their September 21, 2011 meeting. The UTEBIC board unanimously approved this change on October 6, 2011.

10. New option/concentration/emphasis objective:
The University of Arkansas Childhood Education licensure program currently offers two sub-specialty options from which candidates must choose in order to complete the program. They are special education and English as a second language. We are proposing to add the third option of grades 5/6 endorsement for P-4 candidates to prepare more candidates to fill the need in the state for highly qualified teachers in grades 5 and 6. The new option requires 12 hours. Nine hours are those currently required and approved by the Arkansas Department of Education for additional licensure in grades 5 and 6 endorsement. The additional 3 hours is an existing literacy course we believe and hear from our local school district stakeholders will better prepare those who teach these grades. It is a program requirement, but is not required for additional licensure.

To prepare teacher candidates to be successful teachers at the 5th and 6th grade level.

CIED 3053 The Emerging Adolescent: Students will know and apply the developmental characteristics of early adolescents with implications for motivation, instruction, learning and classroom management.

CIED 3043 Introduction to Middle Level Principles and Methods: Students will also demonstrate use of the key components, principles, methodologies and research foundations of middle level education. In addition

CIED 5353 Teaching Students with Diverse Needs in Middle Education Settings: Students will acquire a knowledge base concerning issues involved in successful instruction of persons with special learning needs during the middle years.

CIED 5113 Reading Across the Middle Level: Students will survey methods and materials for teaching reading to early adolescents with field based experiences and critical reflection of the various methods and materials.

Concentration courses will be offered via distance learning, online delivery, as well as on campus.
