Insert here a statement of the exact changes to be made: (1) The program of study was revised to expand course options in the statistical core. ESRM 5012 and 5393 are classes typically taken at the master's degree level so they were eliminated and ESRM 6403, 6533, 6543 were added as Statistical Core choices. (2) Because the degree program is approved for both campus and online delivery, other statistical courses were added to increase course work availability in both settings. Courses added as
options include AGED 5473, HRWD 6323 and 6333, EDLE 699v and 6503, and ADLL 6423. (3) The CIED Core requirements of CIED 6013 and 6603 were eliminated since these courses are required in the PhD in CIED. The elimination of course overlap should assist students in understanding the difference in the EdS and PhD programs of study. (4) Within the CIED Core, the title of CIED 5423 was changed from Curriculum Reconstruction to Curriculum Models and CIED 6053 Advanced Assessment to Program Assesssment, leading to a better alignment of course titles with course content. (5) Because the degree program is approved for both campus and online delivery, additonal program evaluation courses were added to the CIED cores increase availability in course work in both settings. Program Evaluation courses added as options to CIED 6053 include ESRM 6613, EDLE 6213, HRWD 6313, and ADLL 6433. (6) Areas of Study were defined so that students will select from a focused program instead of randomly selecting available CIED courses. The course work in each Area of Study is designed to enhance the knowledge and skills of the student pursuing the degree.

The Ed.S. in Curriculum and Instruction has been an important degree option in CIED for over 2 decades. However, the CIED faculty were having difficulty in utilizing the degree because of out-dated courses, changing methods of instruction and instructional setting, and limited program of study. The program of study have been changed to include more course options in each required area and re-focused to reflect the needs of today's teachers and schools. The impact of other degree programs is negligible. No components will be eliminated. The program changes are merely a reconfiguration of the courses routinely available.

Requirements for the Master of Education Degree: The requirements for the Master of Education degree in Curriculum and Instruction are being changed. Please contact the department or visit the website at www.cied.uark.edu for an update on those changes.

Requirements for the Educational Specialist in Curriculum and Instruction: Flexibility exists in the Ed.S. in Curriculum and Instruction program of study. This flexibility is designed to allow for the occupational needs and professional aspirations of each student. Students seeking an Ed.S. in Curriculum and Instruction as an online student may specialize in one of the following areas: Educational Technology, Special Education, Autism Spectrum Disorders, and Applied Behavior Analysis. Students seeking an Ed.S. in Curriculum and Instruction on campus may specialize in one of the following areas: Teaching English to Speakers of Other Languages (TESOL) or Gifted and Talented Education. Applicants are expected to have completed a master's degree and been accepted into the graduate program by the Graduate School and the CIED faculty in the selected Area of Study. The program of study must include a minimum of 12 hours in the area of study, 9 hours of required CIED courses, 9 credit hours from the research options, and a minimum of 3 credit hours of CIED 680V Ed.S. Project.

## Educational Specialist Degree (Ed.S.)

## Search this catalog

Programs of advanced study leading to the degree of Educational Specialist (Ed.S.) are offered in curriculum and instruction and educational leadership, and may be issued by the Graduate School to those students whose major objective is to develop educational competency in one of these specialized areas. All graduate courses applicable to this degree must be taken on the Fayetteville campus unless otherwise specified.

## Educational Specialist Degree in Curriculum and Instruction (CIED)

Admission to the Program. Students who wish to become candidates for the degree of Educational Specialist in Curriculum and Instruction are expected to first complete work equivalent to the requirements for the master's degree as determined by program faculty and must apply to be admitted to the Graduate School. The application is then sent to the Department of Curriculum and Instruction for admission to the Ed.S. in Curriculum and Instruction (CIED. The applicant will be asked to submit a resume and a brief narrative concerning previous work experiences and education experiences as well as future goals. Since the Ed.S. in CIED has several Areas of Study, the application will be asked to indicate which Area of Study he or she will pursue. This information is used to better match each with a professor who will act as an advisor. Some Areas of Study for Ed.S. in CIED are offered online, but others are offered only on campus. Therefore, it is important for the applicant to indicate which instructional setting is preferred as well as the preferred Area of Study.

Program Requirements. All Ed.S. programs of study in CIED contain a minimum of 33 semester hours of graduate work beyond the master's degree. The program for each student must include the requirements specified in the particular Area of Study to which the student has been accepted; a minimum of nine semester hours of graduate work in Research Methods; a minimum of nine semester hours of required course work in Curriculum, Instruction, and CIED program evaluation; and an original project, research paper, or report for which variable credit no less than three credit hours and no more than six semester hours is required. A grade-point average of 3.25 is required for the Educational Specialist degree program on all graduate hours presented as part of the Ed.S. in CIED.

After a student is accepted into the Ed.S. in CIED, an advisory committee with a minimum of three members will be established, and a program of study will be developed outlining the program of study with its Area of Study. Only the adviser and one other member of the student's committee may be from the Area of Study specified by the student. The committee's responsibilities include the
determination of deficiencies, acceptability of previous graduate work, approval of the candidate's program of study, approval of the required Ed.S. Project, and conduct of a final examination. The final examination will be a comprehensive oral evaluation scheduled near the end of the candidate's program and will include one or both of the following: 1) evaluation of the Ed.S. Project, and 2) evaluation covering material related to the professional preparation of the candidate. A written examination may not be taken to substitute for the oral examination. A written account of the Ed.S. Project will be filed with the Area of Study sponsoring the candidate's program of study. Upon completion of the Ed.S. requirements and after filing for graduation with the Graduate School, the Graduate School confers Educational Specialist in Curriculum and Instruction degree.
