The Collaborative Piano Program is becoming one of the most important piano programs throughout the United States, rivaling the "Solo" Piano Performance degree in numbers and significance. Increasing numbers of excellent pianists realize that even with the solo performance degree, few pianists can make a living by solo performances. Moreover, qualified and experienced collaborative pianists are in high demand because their knowledge of various instruments and voices can assist in the learning process as well as the actual performance. In addition, most college job descriptions for piano faculty positions these days include "collaborating" with fellow faculty members.

Collaborative Piano programs are usually graduate-level programs because pianists who enter these programs must have adequate technical skills and knowledge of musical styles. Moreover, the major difference between "Solo Performance" and "Collaborative Piano" degrees is the repertoire, since collaborative pianists must become familiar with the entire Vocal and Instrumental repertoire, including all duo pieces, concerti (orchestra reduction parts) and chamber music. Hence, pianists must be very accomplished before entering collaborative programs.

The major assets of the collaborative pianist for job placement are the repertoire list and performance experiences. On average, a graduate collaborative piano student will play at least five performances a semester, while a solo performance student would have one or perhaps two solo performances a year. Thus students who have an interest in collaboration will have a head start by studying in a program that specializes in this area of piano playing.

Finally, collaborative piano programs service the needs of the entire department because the students who are in the program will be partnered with other students who need pianists to perform their repertoire. Coaching sessions will benefit both parties because the student instrumentalist/vocalists also learn how to communicate with their future pianists and learn valuable rehearsal techniques.

Anecdotally, since we have had a true collaborative pianist on our staff-we now have two-the entire department has benefited exactly as we had hoped. Student and faculty morale has dramatically increased because both students and faculty alike know that we have true professionals with whom to play; or in the case of students, student-colleagues who are trained in the art of collaboration by professionals. Further a number of pianists in NW Arkansas have indicated interest over the years in the development of such a program at the University of Arkansas.
