This request is to formalize the process which exists in practice under the current Bachelor of Science in Kinesiology (KINSBS) degree program. Instead of having two distinct concentrations under Kinesiology, this request creates stand-alone programs in Exercise Science and Teaching K-12 Physical Education & Health.	It is not anticipated there would be any negative impact on enrollment. As of Oct. 13, 2017, KINSBS had a combined enrollment of 851 students. If anything, both programs could benefit from increased enrollment as these new program names more accurately reflect the degrees.
