Requirements

Requirements for the Doctor of Philosophy Degree: During the first semester of study, all doctoral students will be assigned an advisory committee that will determine their particular programs. Students will select three fields of historical specialization including a minimum of 72 hours beyond the bachelor's degree and a minimum of 42 hours at the 5000-level or above beyond the master's degree. 18 hours of this minimum should be HIST 700V: Doctoral Dissertation.

Students will select four fields of historical specialization. Students will also be required to meet the departmental language requirement by establishing reading competency in at least one foreign language. At the discretion of the student's advisory committee, doctoral students may be required to prove reading competency in additional foreign languages if appropriate to their respective fields of research and study.

After completing the course of study prescribed by their advisory committees (with a minimum 3.0 GPA in all course work for the Ph.D. degree), degree) and satisfying the language requirements, and before students may apply to take the end of the third year of full-time study, doctoral students may apply to take the candidacy examinations. These consist of written exams in each of the three four-specialized fields and an oral

examination. When these examinations have been passed, students may apply for admission to candidacy. Within six months of passing the written and oral **exams, doctoral candidates** exams in all four fields, ABD students will write and defend a dissertation prospectus.

All students must demonstrate a capacity for independent research by the writing of an original dissertation on a topic within their major area of study. Upon admission to candidacy, students will be assigned a dissertation committee with a major professor as chair to direct the research and writing. Under direction of the major professor, candidates will develop programs of reading in the general areas and research techniques pertinent to researching and writing their dissertations.

The student's final examination will be an oral defense of the dissertation.

Students should also be aware of Graduate School requirements with regard to doctoral degrees.

The History Department has a very strong research agenda among its faculty. Since 2005, faculty have produced 49 books, meeting or exceeding the productivity of faculties at our peer institutions nationally. This active research agenda has been supported by numerous outside grants and fellowships as well as internal awards from the department, college, and university.

The Department's primary goal with the PhD program over the next five years is to continue to cultivate a strong research culture among its graduate students, especially in the PhD program where students are increasingly facing a difficult academic job market. The department has begun using programming from Karen Kelsky's The Professor is In (an author and frequent Chronicle contributor) to encourage them to work towards publishing at least one article or book chapter before they complete their studies.

	students' completion time (a point of interest in

	fourth field (typically 3-4 courses), the
	department hopes that individual doctoral
	advisory committees will be able to again
	require doctoral students to enroll in a research
	seminar, in hopes that students might produce
	publishable essays and get a head-start on their
	dissertations. A publishable article is far more
	important on the job market than a fourth field.
