	Description and justification of the request	<p>Changed Other Requirements from "Maximum of 9 hours at the 4000 level" to "Maximum of 9 hours from (a) graduate courses cross listed with courses numbered 4000 or lower and/or (b) courses numbered 4000 or lower."   Many formally 4000 level courses have been switched to 5000 level courses. The change being proposed above brings the curriculum back into alignment with its original intent prior to the change in numbering systems.</p>	<p>This is a minor change to our AGECMS Program, Thesis Concentration, that consists of two parts:\n\n1. Prerequisite Change - due to how the prerequisite was worded previously, as "Survey of Calculus or Higher" students could technically complete our MS Thesis Concentration without having completed a calculus course. Calculus is a very important prerequisite for the Thesis Concentration so the new wording requires that all students have "Survey of Calculus or Higher Level Calculus" as a prerequisite to our Thesis Concentration. The new wording reads: "Six semester hours of mathematics (College Algebra and Survey of Calculus or Higher Level Calculus)"\n\n2. New Course Added - a new course will be added to the MS Thesis Concentration Core Requirements. The course will be one of two Quantitative Options that students will be required to complete.\n\nAGEC 5643 - Agricultural Data Science (in CIM as new course): this course will be offered by a new faculty member, Dr. Aaron Shew, who has a joint appointment with the Department of Agricultural Economics and Agribusiness (Bumpers) and as the Associate Director of CAST (Fulbright). \n\nBecause our MS Thesis Program is a two-year program, the sequencing of these courses will allow thesis students to complete all three Quantitative courses if they so choose, but completing the third course as an elective.   1. Prerequisite Change: Calculus is required for mastery of much of the materials in our Thesis Concentration. Students need this mathematical training in their undergraduate studies to be successful or they need to complete a calculus class as a deficiency once admitted to our MS program. \n\n2. New Quant Course: Students have consistently expressed the desire to have stronger quantitative skills upon completing our MS program and this course will allow us to offer a highly applied quantitative course using the "R" programming language that is increasingly demanded by industry and academia.</p>

Description and Justification for this request	<p>Creating a new master's degree in graphic design.   The new program has been mandated by a portion of an annual endowment from the Walton Family Charitable Support Foundation with additional support for two endowed faculty. This endowment will allocate funds for faculty and student research, travel, visiting designers, and materials/technology to run the program. Beginning in the fall of 2020, five graphic design tenure/tenure-track faculty will be in place with one visiting assistant professor, one senior instructor of practice with four additional projected faculty hires supported by the endowment over the next few years as listed below.</p> <p>\\n \\nA \$120 million endowment by the Walton Family Charitable Trust Foundation was awarded to the School of Art to establish a graduate degree in design considering that there is no stand-alone terminal degree in design in the state of Arkansas. In the formulation of the Master of Design (MDES) degree, a rigorous academic component synonymous with a Research One university and the J. William Fulbright College of Arts and Sciences, which the School of Art resides was realized. The degree equally advances an academic, as well as social emphasis through the endowment embracing a strong emphasis on diversity, inclusion, community, and interdisciplinary scholarship.</p> <p>\\n\\nWithin the research and construction stage of the degree, the program solicited national design educators as virtual and on-campus consultants to provide for additional insight and scholarship. Regarding nomenclature, a consensus among both consultants and faculty, as it pertains to both current and future lenses of the professional and academic arenas, that "Master of Design" or "MDes" is the appropriate degree title.</p>

Meredith's feedback made clear that in our current state, the degree would be better labeled communication design. Communication Design is a more recognizable term that accurately describes the degree course of study. It fits the values of the proposal submitted to NASAD and the expertise of the faculty that will be teaching in the program.
