Web-based Program

The online format provides our institution with the opportunity to engage with instructors that do not live in the Northwest Arkansas region. Importantly, these are exceptionally established music industry practitioners in various fields (management, law). Online delivery of courses in this program provides a connection to these faculty that allows them to teach and engage with our students while maintaining their full-time music industry work.

This certificate focuses on subjects that are critical for musicians in the 21st century that are not covered in our existing courses. The music industry, music law, entrepreneurship, and audio technology/production, are new subject areas in the department. The certificate allow us to offer these subjects in a format whereby they are accessible to music students in any degree plan, not confined to a particular course of study. In this way, we are allowing the greatest number of students to participate in this program. Additionally, because a significant portion of the contemporary music industry involves careers that are outside of music performance/composition/education (the typical offerings in any department of music), this certificate allows students from any major to engage with the music department and apply their skills from other degree plans (i.e., STEM) to music industry subjects and potential careers.

Our department views this certificate as sharing alignment with several aspects of our institution's mission:

-Teaching: The importance of vocational training for musicians, especially in the mechanics of the music industry and entrepreneurship/promotion, is critical for the student success of music majors. This program helps our department address these needs of our students while also increasing the potential number of students (SSCHs) served by the department by bringing in outside majors.

-Research: As a growing interdisciplinary field, music industry studies offers potential research collaborations between multiple arts and STEM units. Currently, our student run record label is an example of such a collaboration and offering this program provides groundwork for future work in this area. Having a music industry credential on our campus is certainly a prerequisite to attracting additional faculty in music economics, law, cultural policy, and other growing areas of scholarship.

-Service: Because this certificate can be taken by non-degree seeking students, it can provide an invaluable service to musicians all around Arkansas. The online delivery method will be especially valuable in this respect. Musicians require continual professional development and this program will serve non-traditional students and working professionals by providing up-to-date content and access to high level faculty in music industry subfields. We anticipate a significant number of non-traditional students to eventually utilize this certificate.

In short, we anticipate this certificate will serve to drive enrollment (majors, non-majors, and non-

traditional, non-degree seeking students), foster student success in a complex labor market, and raise the profile of the department by including new faculty and new subjects.
