R.N. to B.S.N. Option (NURSBS-RNBN)

Program Admission Policies

Step One

Complete the university admission application and associated requirements. Current practicing Registered Nurse (R.N.) applicants will select R.N. to B.S.N. program for their program of study.

Step Two

Upon receipt of all required application material, the university determines applicant qualification for general university admission. If general admission is granted, the application then goes to the nursing department to determine program admission eligibility. Admission criteria verified by the nursing department includes:

Completion of an accredited/state board approved R.N. program.

R.N. licensure status in Arkansas or compact and /or any other state that covers Arkansas. has approved the program. Not all state boards of nursing will accept outside of stateeducation. See program website for the current list of allowedstates. The nursing license must be active and unencumbered. Students admitted to the program will be required to maintain this active, unencumbered status for the duration of their enrollment in the program.

The applicant's R.N. employment status including the following:

R.N.s with 12-months or greater since nursing program completion:

Documentation from current and/or recent employer(s) where applicant is hired as an R.N. including institution or organization name, address, supervisor contact information, area or unit of service, position title, and employment status (e.g. full-time, part-time, per diem). Applicants should include documentation of one of the following:

Employer verification of 1,000-R.N. practice-hours completed within 12-24 months of beginning the program.

Completion of a state board of nursing approved R.N.-refresher courses within 12-24 months of beginning the program. Nursing students enrolled in the final semester of an accredited nursing program may apply and be eligible for conditional program admission upon successful completion of their current nursing program. Students in this category will be

required to submit the following:

Verification of good standing provided from the director or dean of the respective nursing program from which the applicant is transferring (form provided in University application).

Final transcripts (official) to the university and a copy (can be unofficial) to the nursing department upon completion of current nursing education program.

Date of NCLEX exam once scheduled and testing outcome resulting in <u>licensure</u> (see progression for more information <u>below</u>).

Step Three

licensure.

In addition, students may enroll in a maximum of 6 credit hours of course work within theR.N.toB.S.N.program of study and enrollment duration may not exceed one academic semester or 6 months followingPre-R.N.licensure program completion. Step Three Once admitted an academic advisor will evaluate the general education requirements (state minimum core and nursing program prerequisites). Students must complete all program prerequisites before beginning the nursing program courses or in the first term of admission. The academic advisor will assist each student in developing an individualized course progression plan to meet the requirements of the program.

Additional Program Information

Students must be aware of Technical Program Standards as listed in the Student Handbook. If students have questions or concerns about their ability to meet the technical standards or if they need to request reasonable accommodations, they should contact the Center for Educational Access prior to the start of the semester and ensure they request any accommodations needed for both didactic and clinical courses. If accommodations are not secured prior to the start of the semester for clinical courses, students may experience delays in clinical placement and course progression. Professional nursing courses for R.N. to B.S.N. to B.S.N. to B.S.N. students are delivered online through University of Arkansas Global Campus. Clinical practicum experiences are a student-led process using a preceptor model. Students will be required to identify a qualified mentor(B.S.N. Nursing students take level or higher) for the lead in finding NURS 4092 practicum course involving 75 clinical sites and preceptors for each of the clinical courses. hours. Our nursing faculty and staff will support students by communicating the required clinical setting type, providing suggestions for clinical site locations, and utilizing our growing network of clinical site agreements to assist students in finding locations. Students will submit clinical sites and preceptor requests to the nursing school, who will then create the clinical site agreement and verify preceptor eligibility. Clinical course placement is not guaranteed, it varies per term and by site. Students must provide proof of all required clinical paperwork, including required drug screens and background checks, requested by the school of nursing (the most current clinical requirements can be located in the student handbook).

Students admitted to the program may request up to 3 credit hours of previously completed B.S.N.-level course credit in substitution for a core R.N. <u>to B.S.N.</u> <u>toB.S.N.</u> program of study course. The nursing faculty evaluate core R.N. to B.S.N course substitution petitions for eligibility. Only courses taken within the last five years will be eligible for review.

The minimum number of hours required to receive a baccalaureate degree at the University of Arkansas is 120 semester hours. The Nursing major is exempt from the eight-semester degree plan since the program is admissions-based.

Progression, Withdrawal, and Dismissal for R.N. to B.S.N. to B.S.N. program (NURSBS-RNBN)

For progression in the nursing program, only grades of "C" or above will be accepted. Note that the Eleanor Mann School of nursing uses the following grading scale and exampolicy:GradingScale:A = 92-100% B = 83-91% C = 75-82% D = 62-74%

F = below 62%ExamPolicy:A 75% average on class exams is necessary to pass thecourse.Once this criterion is met, other course grades will be factored into the finalgrade.Course Failure on the second attempt. The course must be passed on the secondattempt. If a student earns a "D," "F," or withdraws from the second attempt, this results in dismissal from the nursing program. If a student earns a "D" or "F" in a second course, the student will be dismissed from the program and will not be eligible for re-admission.

Students admitted prior to taking their NCLEX RN exam must report successful licensure within 6 months of programstart. If at any point in unsuccessful on NCLEX RN exam, the duration of the program, the student's nursing license becomes encumbered or inactive the student must notify the school of nursing immediately. will not be permitted to enroll in subsequent semesters until licensed: Licensed students who do not maintain an active, unencumbered license will be dismissed from the program without eligibility to reapply. If the nursing department discovers a student has an encumbered or inactive license, or has falsified any official licensing information, the student will be immediately dismissed from the nursing program, and a formal report will be shared with the Academic Integrity Board of the University of Arkansas and the student's state board of nursing will be notified.

For licensed nurses, the school of nursing is a mandated reporter. Positive drug screens, positive background checks, and/or ethical violations may be reported to the student's state board of nursing and may result in consequences ranging from administrative withdrawal to program dismissal. If a student is arrested during their program of study, the school of nursing should be notified immediately, and the student will become ineligible for clinical courses pending the outcome of an investigation and/or judicial process. Failure to report is considered a violation of the Code of Ethics.

The school of nursing will comply with the policies, rules, and regulations set by the Arkansas State Board of Nursing.

Failure to comply with state board rules and regulations will result in program dismissal.

Students who do not complete all required compliance documents as specified in the Student and Clinical Handbooks by the due date will not be enrolled into the clinical course and must defer to the next available semester upon completion of pending compliance requirements. Students must maintain compliance in EXXAT at all times while enrolled in practicum courses. If students are non-compliant in any area, they will not be allowed to attend practicums until compliance is met. Any falsification or alteration of EXXAT documents are subject to investigation by the Office of Academic Integrity. The appropriate disciplinary action will be determined and may include dismissal from the program. See also practicum handbook.

If a student taking a didactic course with an associated practicum in the same semester decides to withdraw from the didactic course, they must also withdraw from the practicum.

Students should note that any violation of the Eleanor Mann School of Nursing policies or code of ethics can result in course failure and/or dismissal from the program without prior warnings (see student handbook).

Three <u>Perform</u> performance improvement plans are evidence of ance <u>Improvement Plans</u> are evidence of a pattern of behavior that contradicts our policies and code of ethics. A student with three <u>Performance Improvement Plans</u> performance improvement plans will meet with program administration and will be subject to dismissal. A student dismissed from the school of nursing will be asked to self-withdraw from all courses or will be subject to administrative withdrawal.

Repeating Didactic/Clinical Practicum Courses (NURSBS-RNBN)

A student who needs to repeat a course in which they were unsuccessful must make an academic success plan with petition to the Academic Advancement faculty to qualify Student Affairs Committee in nursing and are encouraged to retake do so as soon as they are aware of the need to repeat a course. An academic success plan will be implemented upon approval as outlined by this committee. Students that withdraw or are unsuccessful will be reenrolled on a space-available basis according to the following priority system: Priority Groups for Placement in Required Courses Priority Groups for Placement in Required Courses

First Priority – Continuing students in good academic standing ranked by admission cohort.

Second Priority – Students repeating a course due to withdrawal or failure.

Spaces in clinical practicum courses are limited and tightly controlled by accreditation, the State Boards of Nursing, and clinical agency policies. Space in Didactic courses are limited to space available. A student re-enrolling in a Clinical Practicum Course for any reason Course (whether due to illness, course failure, or other reasons) will not be assured a clinical placement space in current or subsequent terms. courses.

Readmission Policies

Any student whose enrollment in the professional program of study has been interrupted may seek readmission following the steps below:

<u>For interruptions unrelated to dismissal, seek</u> readmission into the University of Arkansas (if <u>applicable</u>) <u>applicable</u>). <u>Notify the program of readmission intentions and inquire about current eligibility.</u>

Readmission will not be considered for any student dismissed from the School of Nursing

Nursing who obtained a "D" or "F" in one nursing course and was unable to make a "C" or better upon repeating this course, who fails a second course, or who was dismissed from a course due to safety, ethical, or dishonesty issues.

Exceptions to this policy will be considered by the Student Affairs Committee in nursing on an individual basis and only in the presence of extenuating circumstance. Exit Policies

Students must complete the requirements for the degree within five years of enrolling in the first upper-level nursing course. Nursing credits must be reevaluated (and may need to be repeated) if the student does not complete the Professional Program of Study within the five-year limit.

In addition to the program requirements, students must meet the university and college graduation requirements. This curriculum is subject to change to comply with national accreditation and the Arkansas State Board of Nursing Standards.
