Donna Graham called the meeting to order at 2:37P.M.

- 1. The minutes for the February 26, 2010 meeting were approved.
- 2. Course Change Proposals:
 - A. Undergraduate course change proposals (<u>Table A</u>) were approved without opposition and will be forwarded for the April 14, 2010 Faculty Senate meeting.
 - B. Graduate and Dual course change proposals (<u>Tables B & C</u>) were approved without opposition and forwarded for the April Graduate Council meeting.

3. Old Business:

Response to the University General Education Core Curriculum Committee concerning the proposed diversity requirement was drafted by Chuck Adams who forwarded a first draft for consideration. Chuck was unable to attend the meeting. The response document was discussed and several suggestions were to be forwarded to Chuck Adams for consideration as he prepares the document for presentation at the April UCPC meeting.

- 1. The last sentence in paragraph one needed to be reworded as the UCCC does not have responsibility for enrollment management or resource allocation and could not address the issue.
- 2. Several college representatives suggested that their student's schedules are very restricted and having this additional requirement might discourage minors. They also did not believe that one course

should make a "Diversity Area" and that the diversity requirement should be present throughout the "Core" courses.

4. New Business:

- . Proposed undergraduate program change for the Bumpers College of Agriculture, Food and Life Sciences, Department of Horticulture– HLTSBS BSA, Horticulture, Landscape and Turf Sciences (<u>Table 1</u>, <u>Attachment 1A</u>) was presented by Donna Graham. The program change requested to allow students who exempt from ENGL 1013 and ENGL 1023 to enroll in general elective hours rather than additional English or communication hours. The proposal was approved without opposition and will be forwarded for consideration at the April 14, 2010 Faculty Senate meeting.
- A. Proposed undergraduate program change for the College of Education and Health Professions, Department of Curriculum and Instruction CATEBS BSE, Career and Technical Education (Table 2, Attachment 2A) was presented by Michael Miller. The proposal requested to remove one of the two HLSC Wellness Concepts or HLSC 1103, Personal Health and Safety, and PEAC 1621, Fitness, as program requirements and increase the general electives by three hours for the Business Education and Family Consumer Sciences concentrations; and remove PSYC 2003, General Psychology, as a requirement and increase electives by three hours for the Technology Education concentration. The proposal was approved without opposition and will be forwarded for consideration at the April 14, 2010 Faculty Senate meeting
- B. Proposed undergraduate program change for the College of Education and Health Professions, Department of Curriculum and Instruction CHEDBS BSE, Childhood Education (<u>Table 2</u>, <u>Attachment 2B</u>) was presented by Michael Miller. The program change requested to delete HLSC 1002, Wellness Concepts, PEAC 1621, Fitness Concepts, and COMM 1313, Fundamentals of Communication, as requirements and add six hours to electives. The proposal was approved without opposition and will be forwarded for consideration at the April 14, 2010 Faculty Senate meeting.
- C. Proposed undergraduate program change for the College of Education and Health Professions, Department of Health Science, Kinesiology, Recreation and Dance HLSCBS BSE, Health Science (<u>Table 2</u>, <u>Attachment 2C</u>) was presented by Susan Mayes. The program change requested to delete three required courses, add two other courses as requirements, and many other changes. The proposal was approved without opposition and will be forwarded for consideration at the April 14, 2010 Faculty Senate meeting.
- D. Proposed undergraduate program change for the College of Education and Health Professions, Department of Health Science, Kinesiology, Recreation and Dance KINSBS BSE, Kinesiology (Table 2, Attachment 2D) was presented by Susan Mayes. The program change requested to remove HIST 2003 and HIST 2013 as specific requirements in the University Core and for the Applied Exercise Science concentration add SOCI 3033, Social Data Collection, as a statistics requirement with lower level course acceptable with advisor approval. The proposal was approved without opposition and will be forwarded for consideration at the April 14, 2010 Faculty Senate meeting.

- E. Proposed undergraduate program change for the College of Education and Health Professions, Department of Rehabilitation, Human Resources and Communication Disorders CDISBS BSE, Communication Disorders (<u>Table 2</u>, <u>Attachment 2E</u>) was presented by Michael Miller. The program change requested to delete WLIT 1113, World Literature, from the additional general studies course requirements. The proposal was approved without opposition and will be forwarded for consideration at the April 14, 2010 Faculty Senate meeting.
- F. Proposed undergraduate program change for the College of Education and Health Professions, Department of Rehabilitation, Human Resources and Communication Disorders PCDIS Pre-Communications Disorders (Table 2, Attachment 2F) was presented by Michael Miller. The program change requested to add a pre-code for students who have not completed the process for formal admission into the communication disorder major. The process requires an application and an interview. The proposal was approved without opposition and will be forwarded for consideration at the April 14, 2010 Faculty Senate meeting.
- G. Proposed graduate change for the Department of Business Administration BUSNGC Graduate Certificate in Business (<u>Table 3</u>, <u>Attachment 3A</u> and <u>Attachment 3B</u>) was presented by Bill Curington. The program change requested to add a new graduate certificate program in Business for non-business graduate students. The proposal was approved without opposition and will be forwarded for consideration at the April Graduate Council meeting.
